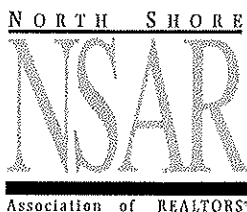

## 2009 Installment Plan

**The 2009 Installation Plan will be a four-payment schedule**

To be on the plan you must authorize NSAR to deduct the four payments directly from the credit card on the authorization form.



### **Installment Plan Schedule:**

\$131.75 Due on September 30, 2008

\$131.75 Due on October 31, 2008

\$131.75 Due on November 30, 2008

\$131.75 Due on December 31, 2008

**Total 2009 Dues \$527.00 (includes \$12.00 service Fee)**

### **Q: What is the advantage for me to use the installment plan?**

**A:** The advantages of using the installation plan would be ease and convenience of payments.

### **Q: What if I don't get my form in by September 15, 2008?**

**A:** If you join the plan on or before September 15—30, 2008, NSAR will deduct only the first payment. If you join the plan after September 30, 2008, NSAR will deduct any prior payments as well as the current payment that is due. For instance if you join on November 15th you will pay September and October and then November at the end of the month.

### **Q: Will NSAR be offering the early payment education voucher credit?**

**A:** Yes, NSAR will be offering the \$25.00 early payment voucher that is good towards education classes for 2009. The full dues payment of \$527 needs to be paid in full by November 30, 2008 to be eligible. If you are enrolled in the installment plan and would like to make the December payment with your November payment to be eligible, call Michelle at 978-232-9410 and your dues payment will be processed by November 30, 2008.

### **Q: How do I join the 2009 Installment plan?**
